


BEAD OVERVIEW



BEAD PROGRAM BACKGROUND

What is the BEAD Program?



- The Broadband Equity, Access, and Deployment (BEAD) Program was created by the bipartisan Infrastructure Investment and Jobs Act (IIJA)
- Allocates \$42.45 billion of federal funding to all 50 states,
 Washington D.C., and territories
- Administered by the National Telecommunications and Information
 Administration (NTIA)
- Goal of expanding high-speed internet access through infrastructure deployment and adoption programs
- Prioritizes funds for unserved locations first (those that cannot get internet service of 25/3 Mbps) and underserved second (those that can get internet service between 25/3 and 100/20 Mbps only)

THE WYOMING BEAD PROGRAM



Wyoming was allocated \$348 million to support the deployment of broadband infrastructure


- WBO has submitted to the federal government the first three of four required BEAD plans, including the second volume of the Initial Proposal, which describes the state's grant program design, proposed subgrantee selection process, grant application scoring criteria, plans for workforce development, and affordability strategies, among other relevant information

The Project Snapshot section aims to quickly capture project information to allow for interim reporting. Requested information and materials include:

The Financial Capability section will capture project-specific financial information.







PROJECT STAFFING & LABOR



The Project Staffing & Labor Requirements section will capture additional information on the subgrantee applicant's workforce plans and structure.

OWNERSHIP INFORMATION



The Ownership Information section will allow subgrantee applicants to update ownership information previously submitted during Prequalification, if applicable.
