

Broadband Equity, Access, and Deployment (BEAD) Program FAQs

Answers are provided for the reference of all subgrantee applicants; questions have been condensed, consolidated, and edited for clarity.

Application Phase

1. Are the maps finalized from the Challenge Process? If not, when will these be finalized? I presume we can't design projects until the location map is fully solidified, since it is subject to change.

Results from the BEAD Challenge Process have been submitted to NTIA; WBO is awaiting approval. Once NTIA approves the results, WBO will release the location map and data along with subgrantee application materials.

If WBO does not receive NTIA approval of its BEAD Challenge Process results before the planned opening of WBO's Subgrantee Application Phase, WBO will publish preliminary Broadband Serviceable Location (BSL) data seven days before the Subgrantee Application Phase begins. Then, when NTIA approves the Challenge Process results, WBO will publish a final version of the BSL data. At that point, WBO will also extend the Subgrantee Application Phase window if needed to allow subgrantee applicants enough time to complete their project designs.

2. When will WBO release benchmark pricing for each project area?

WBO will release the benchmark pricing seven days before the opening of the Subgrantee Application Phase to provide subgrantee applicants sufficient time to review and design project areas.

3. If an entity submits an application that uses a blend of fiber and fixed wireless solutions, would that application be scored as a non-priority application?

Yes. Only projects that are end-to-end fiber will be considered "Priority Broadband Projects." As defined by the BEAD Notice of Funding Opportunity (NOFO):

"The term 'Priority Broadband Project' means a project that will provision service via end-to-end fiber-optic facilities to each end-user premises. An Eligible Entity may disqualify any project that might otherwise qualify as a Priority Broadband Project from Priority Broadband Project status, with the approval of the Assistant Secretary, on the basis that the location surpasses the Eligible Entity's Extremely High Cost Per Location Threshold... or for other valid reasons subject to approval by the Assistant Secretary." 1

4. Do we need to supply a Letter of Credit Certification during the Application Phase?

Yes. During the Application Phase, subgrantee applicants are required to provide either a letter of credit or a performance bond from their financial institution. For guidance, please see Section 2.4.11.3 of Wyoming's Initial Proposal Volume II.³

5. Where can I find the benchmark spreadsheet?

The Wyoming BEAD Benchmark Spreadsheet is available on the WBO BEAD webpage under Grant Application Materials: https://broadband.wyomingbusiness.org/bead/application-awards/.

6. If an area or parts of an area get funded by the USDA ReConnect Round 5 program, will those locations be made ineligible for BEAD funding?

Yes. Between now and its submittal of the Final Proposal to NTIA, WBO will publish locations served through ReConnect upon notification or certification that the grants have been completed. WBO will also review and remove locations served through Capital Projects Fund (CPF) grants under the Connect Wyoming program and any other grant-funded programs with enforceable commitments. WBO will publish locations deemed ineligible for BEAD funding as they are verified.

7. When will the maps be available? I understood that preliminary maps would be available for preview seven days before the application portal opening date.

Due to the time required to build maps based on the Project Area Units (PAU), WBO is not able to provide preliminary maps seven days before the application opening date of October 21. However, WBO plans to make maps available on October 21. In the meantime, all the data for eligible location, PAU identifier, and benchmark pricing are now available on the WBO BEAD webpage under Grant Application Materials: https://broadband.wyomingbusiness.org/bead/application-awards/.

8. Are multiple applications allowed?

Yes. You can combine Project Area Units (PAU) into a single application. You can also apply for a PAU individually. For more details, please see the September 23 webinar, BEAD Grant Program Design, accessible from the WBO BEAD webpage under BEAD Grant Application Webinar Recordings: https://broadband.wyomingbusiness.org/bead/bead-webinars/.

9. Can you explain the difference between Project Area Units and Census Block Groups?

WBO's Subgrantee Application will utilize Project Area Units (PAU) as the foundational geographic unit. The PAUs are constructed to aggregate unserved and underserved locations within a Census Block Group (CBG) into smaller units. Multiple PAUs may be part of a CBG. 10. The published list of locations didn't include information on the serviceability of locations. Should subgrantee applicants use the current list of Challenge Process results as a reference for serviceability of locations?

Yes, subgrantee applicants should use the latest eligible location results until WBO has received NTIA approval on the final list of eligible locations. While the current list of eligible locations has FCC IDs only, subgrantee applicants can use their Tier D license to match the needed latitude/longitude information and serviceability type from the CostQuest fabric. To access eligible location data, select Eligible Locations from the WBO BEAD webpage, accessible in the "data" section under BEAD Grant Application Materials: https://broadband.wyomingbusiness.org/bead/application-awards/.

11. Why did Question 3.9 for Non-Priority or Alternative Technology subgrantee applicants change from asking if the network could reliably deliver at least 250/50 Mbps to now asking if the network can reliably deliver at least 100/20 Mbps?

The original version of Question 3.9 incorrectly referenced a speed of 250/50 Mbps. Question 3.9 has been updated to reference the BEAD baseline speed requirement for Reliable Broadband Service of 100/20 Mbps. Subgrantee applicants are required to select "Yes" or "No" from the dropdown menu.

12. What is the updated guidance for Question 3.9A for Non-Priority and Alternative Technology subgrantee applicants and why was this update made?

For Question 3.9A, subgrantee applicants are now required to include in the first sentence of their narrative response the tier of service speeds their network can reliably deliver while maintaining latency of no more than 100 ms. This additional information will help WBO score subgrantee applicants in the "speed of network and other technical capabilities" category in the Subgrantee Selection Scoring Rubric. Speed tiers and corresponding scores are listed below:

Speed tier 1	100/20 Mbps up to 500/20 Mbps	0 points
Speed tier 2	500/20 Mbps up to 1 Gbps/35 Mbps	2 points
Speed tier 3	1 Gbps/35 Mbps or higher	5 points

For a subgrantee applicant to receive these points, the state's evaluation must confirm that the proposed network design can deliver the performance level to all eligible locations within an application, including a reasonable assessment of how the proposed network can scale by adding incremental capacity in a cost-effective manner as new customers are added. 13. Question 2.7 asks how many people we have hired for this project. Is this asking how many people we have employed who will work on the projects or is it asking how many people we have hired specifically to cover BEAD projects?

Provide an estimate of the number of people, and in what roles, you have hired or intend to hire for this project only. Do not include personal contact information (e.g., home address, personal phone number) in your response.

The response should detail the anticipated number of personnel that will be hired to carry out the project and should also detail the roles for which the personnel will be hired. If you have hired or will hire additional people to cover multiple BEAD projects, of which this project is one, you may use a percentage based on the amount of time the person will work on this project.

Upload the response to the portal as a file in PDF, Word, or Excel format. The file name must include "2-7-project-roles" to be accepted by the portal.

14. Is there a BEAD map user guide?

Yes. The BEAD Program Broadband Map User Guide, BEAD Application Map, and Map PAU Data File are all available from the WBO BEAD Application Map webpage:

15. There are locations in our PAUs that cannot be reached wirelessly or with fiber. Since we have to propose a solution for all locations in a PAU, the only other option will be satellite. The satellite design template requires the applicant to certify that it will meet the BEAD network requirements. Because our company does not operate our own satellite network, nor does it have resale agreements with satellite providers, we cannot attest to the performance of another provider's network. How should we navigate this scenario?

Subgrantee applicants must submit proposals that include all eligible locations within the Project Area Units (PAU) they are proposing, regardless of the difference between the proposed grant request and the PAU reference price. Subgrantee applicants must also submit proposals only for the applicable technology types (fiber, reliable broadband, or alternative technology) they can provide.

Given these requirements, WBO understands that a proposal may exceed the PAU reference price. This can be addressed in negotiations, which allows WBO to work with subgrantee applicants to alter the terms of their proposals, including but not limited to descoping of high-cost locations. For PAUs that receive no proposals during the Subgrantee Application Phase, WBO will have the option of contacting prequalified ISPs (those approved in the BEAD Prequalification Phase) for direct negotiation. Therefore, a prequalified ISP could choose not to bid on a given PAU and instead wait to see if WBO receives any proposals for the PAU. If WBO does not receive proposals for the PAU, WBO may contact that prequalified ISP for negotiation on the PAU.

16. Can you clarify the requirements for the Professional Engineer providing the project certification? The Professional Engineer providing the project certification must be licensed, though it is not required they be licensed in Wyoming. Per the NTIA Conditional Limited Programmatic Waiver and Clarification of Professional Engineer Certification, issued in March 2024, the Professional Engineer's license may be in any of the 56 Eligible Entities.

17. Can you clarify the requirements for the attorney providing the legal opinion?

For issues and compliance related to Wyoming law and regulations, the attorney providing the legal opinion must have an active status with no disciplinary charges pending and no public discipline imposed by the Wyoming State Bar. For issues and compliance related to federal law and regulations, the attorney providing the legal opinion must have an active state law license with no disciplinary charges pending and no public discipline imposed.

18. Are applicants required to bid on, and serve, 100 percent of unserved/underserved locations within a CBG or PAU?

WBO would like to see project applications that include all unserved and underserved locations (e.g., Broadband Serviceable Locations (BSL)) in the Project Area Unit (PAU), regardless of cost. Applications that include all BSLs are considered compliant with BEAD requirements for universal service and WBO will prioritize these for negotiation. Applications that do not include all BSLs will be accepted but considered for negotiation only if there are no compliant bids for a PAU. If you have extenuating circumstances that keep you from including all BSLs in a PAU, you may add notes on technical feasibility or limitations in the Technical Narrative.

19. Are applications going to be ranked statewide and not just for overlapping CBGs/PAUs? If so, I question the fairness of this when the maximum points from local government letters of support will be different in different parts of the state. Some CBGs have zero, one, two, or three municipalities. I also question why letters of support don't count from county governments.

WBO encourages subgrantee applicants to obtain letters of support from municipalities. Per the Initial Proposal Volume 2 requirement (IPv2, p. 62), subgrantee applicants will earn additional points based on letters of support from local and Tribal governments only and not from county governments.

Please note that unlike the Capital Project Funds program grants, WBO's BEAD program does not use a statewide ranking by which proposals with the highest scores get awarded. Because BEAD seeks to achieve universal coverage in Project Area Units (PAU) across the entire state within an overall budget, each project is evaluated in the context of the PAU it serves. A subgrantee application in a PAU is not in direct competition with applications in PAUs in other parts of the state. An applicant in a PAU that has one municipality is therefore not at a scoring disadvantage as compared to an applicant in a PAU that has two municipalities (and could therefore receive two letters of support). When two or more subgrantee applicants propose in a PAU, they each have an equal number of potential local and Tribal

governments from which they can receive letters of support – and those governments can choose to provide letters of support for more than one applicant.

- 20. What will be the process for requesting/receiving waivers of the 25 percent matching requirements in non-extremely high cost per location threshold (EHCPLT) Census Block Groups? WBO encourages applications that meet NTIA's match requirement, which is 25 percent for projects that do not include high-cost areas. However, NTIA has a mechanism for the State to request match waivers in the subgrantee selection process. During negotiations, WBO will consider the match waiver as an option to best utilize the funding available to the state.
- 21. The scoring matrix indicates a 1 Gbps commitment for affordability; does this mean there are no points given for 100/20 and how does that align with the Initial Proposal Volume 2 that discusses the \$70 as the low-cost option for 100/20? Assuming, then, that projects which may be end-to-end fiber but which may not be 1 Gbps throughout would be scored lower on the spectrum?

 The question touches on two separate requirements in the state's Initial Proposal Volume 2 (IPv2):
- 1) Under the "Affordability" primary criteria, "all applicants must submit the price for a 1 Gbps download/1 Gbps upload internet service plan for priority projects (or 100 Mbps download/20 Mbps upload internet service plan for non-priority projects) that will be offered to all BEAD-funded BSLs within the service area after deployment is completed." (See IPv2, pp. 55-59.) Up to 15 points will be awarded for this pricing based on the scoring methodology. (See IPv2, pp. 59-60.)
- 2) All subgrantee applicants must provide a \$70 low-cost broadband service option at 100/20 Mbps as a basic requirement to participate in the BEAD program. No points are provided for meeting this requirement. (See IPv2, pp. 130-134.)
- **22.** Are pre-application expenses allowable? If so, is there a percentage threshold and what is that? According to the BEAD NOFO, eligible uses of BEAD program funds are determined in accordance with cost principles identified in 2 CFR, Part 200. "Costs must be reasonable, necessary, allocable, and allowable for the proposed project or other eligible activity and conform to generally accepted accounting principles." (NOFO p. 81) The NOFO also states that funds committed to an award may only be used to cover allowable costs incurred during the period of performance, except for certain reasonable pre-award expenses, and for allowable closeout costs incurred during the grant closeout process.

Pre-award expenses are detailed in 2 CFR 200. Per §200.458: "Pre-award costs are those incurred prior to the effective date of the Federal award or subaward directly pursuant to the negotiation and in anticipation of the Federal award where such costs are necessary for efficient and timely performance of the scope of work. Such costs are allowable only to the extent that they would have been allowable if incurred after the date of the Federal award and only with the written approval of the Federal awarding

agency. If charged to the award, these costs must be charged to the initial budget period of the award, unless otherwise specified by the Federal awarding agency or pass-through entity."

Per the BEAD NOFO (p. 39), eligible uses of funding in connection with last-mile broadband deployment projects include the following:

- 1. Construction, improvement, and/or acquisition of facilities and telecommunications equipment required to provide qualifying broadband service, including infrastructure for backhaul, middle-and last-mile networks, and multi-tenant buildings.
- 2. Long-term leases (for terms greater than one year) of facilities required to provide qualifying broadband service, including indefeasible right-of-use (IRU) agreements.
- 3. Deployment of internet and Wi-Fi infrastructure within an eligible multi-family residential building.
- 4. Engineering design, permitting, and work related to environmental, historical and cultural reviews
- 5. Personnel costs, including salaries and fringe benefits for staff and consultants providing services directly connected to the implementation of the BEAD Program (such as project managers, program directors, and subject matter experts).
- 6. Network software upgrades, including, but not limited to, cybersecurity solutions.
- 7. Training for cybersecurity professionals who will be working on BEAD-funded networks.
- 8. Workforce development, including Registered Apprenticeships and pre-apprenticeships, and community college and/or vocational training for broadband-related occupations to support deployment, maintenance, and upgrades.

23. Do multiple PAUs in one application have to be contiguous?

No. Project Area Units (PAU) do not need to be contiguous.

24. If a company bids on multiple PAUs in a single application, if one PAU is excluded, does the entire application get discarded or just the PAUs that are not accepted?

If a subgrantee applicant bids on multiple Project Area Units (PAU) in an application, and one or more PAUs are not selected by WBO, the entire application is not discarded. For example, if an application has five PAUs and two are not selected for an award, the remaining three PAUs will still be considered by WBO. If these meet scoring and eligibility criteria, and are competitive proposals, WBO can conduct negotiations with the subgrantee applicant to serve those PAUs.

25. Do all PAUs in a CBG have to be served if only one PAU in the CBG is of interest?

An application must include at least one Project Area Unit (PAU). You do not need to submit an application for an entire Census Block Group (CBG).

26. How does WBO intend to address long drop, extremely high-cost locations? Are those handled in a descope? Should applicants identify any such locations in their applications?

WBO encourages subgrantee applicants to budget for and include all locations in a PAU (including long drop, extremely high-cost locations), because applications that propose to serve all locations will be prioritized for negotiations, which may include descoping certain locations. Applicants can identify

extremely high-cost locations in the Technical Narrative. This information will also be covered during negotiations.

27. Will an ISP be considered for a project if they put in for 80 percent coverage of locations? Must the project cover 100 percent?

As noted in FAQ 18 above, applications that address 100 percent of the Broadband Serviceable Locations (BSL) are encouraged; these applications will be considered compliant in the Application Phase and will be prioritized for negotiation. Applications that do not address 100 percent of BSLs are not disqualified but will have a lower priority for negotiation.

28. When will the Application Phase close?

The Application Phase will be open to at least January 10, 2025. If NTIA approves Wyoming's BEAD Challenge location data after November 26, 2024, then the Application Phase will extend 45 days from the date of that approval.

29. How do project-specific resumes differ from key personnel resumes? Can we use the same resumes if the key personnel will be overseeing the projects?

Resumes in the Prequalification Phase highlighted the qualities and capabilities of your organization's leadership. Resumes in the Application Phase should highlight individuals who will work on the specific project in your application. Depending on your organization's size these may or may not be the same people.

30. What should we do if we find a location that's not a BSL?

For the purposes of the application, please submit for the entire Project Area Unit. Please identify ineligible locations in the Technical Narrative portion of your application. After the Application Phase, WBO will work with NTIA to descope locations that are not eligible.

31. If we're proposing a hybrid fiber/wireless solution with speeds ranging from 1Gbps/1Gbps to 100/20 Mbps, what speed tier should we go with (Application Guide, pp. 11-12)?

The speed tier selected should represent the best tier of service the subgrantee applicant can provide to **every** BSL in the project areas.

32. You answered that WBO would like to see all locations in a Project Area Unit in the application, but is it required?

Subgrantee applicants are encouraged to include all Broadband Serviceable Locations (BSL) in their applications, regardless of the cost against the benchmark. Applications that include all BSLs are considered compliant with BEAD requirements for universal service and WBO will prioritize these for negotiation. Applications that do not include all BSLs will be accepted but considered for negotiation only if there are no compliant bids for a PAU. We encourage subgrantee applicants to submit

applications that support your organization's business case, while knowing that applications addressing 100 percent of locations will be prioritized.

33. Will attorney fees for legal opinion and professional engineer fees for project certification be allowable pre-award expenses?

Fees for the legal opinion and project certification are not considered allowable pre-award expenses per the BEAD NOFO. (See question 22 above.)

34. Will you add back in any FCC-identified RDOF default locations for this BEAD round?

Any locations that are determined to be Broadband Serviceable Locations as a result of the BEAD Challenge Process and approved by NTIA will be included in the final location list.

35. Is the Reference Price number meant to be the total cost for end-to-end fiber for all the BEAD locations in a PAU?

Reference pricing is based on CostQuest pricing, but it is an amalgamation of different technology types including fiber, fixed wireless, and satellite. The total reference price must add up to the total funding the state has available and must be distributed across all Project Area Units (PAU).

36. What are your current estimates or best guess at a range for the extreme high-cost threshold? While reference pricing sets a benchmark for estimated costs per Project Area Unit (PAU), the Extremely High Cost Per Location Threshold (EHCPLT) will be determined by actual costs proposed in project applications. WBO will not determine the EHCPLT until after applications are reviewed.

37. Is CBG no longer being used to determine project areas? Is PAU, which may not match the original CBG groups, now being used?

WBO is using the Project Area Unit (PAU) as the minimum project area for an application. PAUs are subsets of a Census Block Group (CBG). One or more PAUs may make up a CBG; no PAUs cross CBG boundaries. An application must address at least one PAU. A subgrantee applicant that wants to serve an entire CBG can select all the PAUs that make up the CBG.

38. Given the scoring criteria where 50 points are based on the benchmark calculation, if a Project Area Unit has a build cost that is double the benchmark amount, ISPs could get a 0 out of 50. Would they be considered for negotiations in those instances?

If an application is competitive in relation to other applications received for a given Project Area Unit (PAU), WBO can conduct negotiations regardless of the application's score against the benchmark.

39. Please can you provide some further clarification on question 4.1A and how you are calculating "sufficient excess conduit"? Is there any parallel to WYDOT's spare duct policy?

To determine "sufficient excess conduit," WBO is using the following requirement from the BEAD NOFO (Section IV.C.2.b.ii, p. 66):

ii. Conduit Access Points - Any Funded Network deployment project that involves laying fiber-optic cables or conduit underground or along a roadway must include interspersed conduit access points at regular and short intervals for interconnection by unaffiliated

entities. Where a project proposes to lay conduit, Eligible Entities shall require prospective subgrantees to propose to deploy a reasonable amount of excess conduit capacity and to propose a conduit access point interval as part of the grant application process and shall consider the adequacy of the prospective subgrantee's proposed excess conduit capacity and access points when evaluating the application.

If an application includes infrastructure in the WYDOT rights-of-way, the requirement for conduit and access points detailed in the WYDOT Shared Resource Agreement (SRA) should be detailed in the response to question 4.1A because it addresses future capacity.

40. When we talk about scoring and "BEAD funding request" as a percentage of the "benchmark" does that include or exclude match? In the example included in the BEAD Application Scoring Criteria webinar on 9/30/2024, is the 40% calculated including or excluding match? If a subgrantee applicant's cost is 40% of the benchmark, the subgrantee applicant will receive 40 points, calculated using the following formula: 40 – (0.4*25) = 40 points received. If I understand this scoring correctly, then, there could be very few to no points if the "funding request" matches or exceeds the benchmark?

The BEAD funding request should exclude match. Total project cost = BEAD funding request + match. For more information, see:

In addition, note that WBO will review all applications and can conduct negotiations regardless of the application's score against the benchmark.

- **41.** Is the pro forma specific to the project or for the entire company? The pro forma is project specific.
- 42. Can you be more specific on how you will define a reasonable amount of extra conduit? Our engineering consultants doing our design have seen this handled differently in other states; some states have asked for a vacant 1.25" duct, and others have asked for everything to be in an oversized 2.5" duct with space for future fibers. We want to ensure that we are designing to the required specifications and that the cost estimates are as accurate as possible.

The funding allocation to Wyoming for the BEAD infrastructure program is limited. As a result, WBO is not designating a specific size or conduit capacity in areas your design includes conduit placement, beyond the permitting requirements as mentioned previously. WBO requires subgrantee applicants to detail in their Technical Narrative (for Question 4.1A) how a reasonable amount of excess capacity is available in their design. Examples could include excess fiber capacity for growth or open network possibilities, spare micro duct, additional maxcell innerduct, etc. The narrative will be evaluated as part of the overall design review of the application and is not part of the scoring rubric.

43. In our project application, how should we capture eligible locations that won't be served by BEAD? WBO has updated guidance for Question 4.2 to require subgrantee applicants to upload a single zipped file folder containing two (2) zipped subfolders:

- Zip A to include shapefiles for network design (required for all applications)
- Zip B to include the completed template and additional evidentiary materials for Non-Served BEAD eligible locations (required only if applicable for your proposed project). If applicable to your project, this folder must contain:
 - A completed "Non-Served Locations" spreadsheet to identify BEAD-eligible locations that may not be served by your proposed project. The template spreadsheet is available on the WBO BEAD Grant Application webpage. You must provide the correct Reason Code in the spreadsheet.
 - Evidentiary materials for each location in the spreadsheet to substantiate your claim for non-service

The zipped file folder must include "4-2-shapefile" in the file name (i.e., "4-2-shapefile.zip") to be accepted by the portal.

Note: The removal of the proposed locations in Zip B is dependent on NTIA and WBO approval. The submission of these locations and related evidentiary materials does not guarantee the removal of the locations from the proposed project.

44. Wyoming's IPV2, Section 2.4.14.1 Legal Compliance states that "WBO intends to publish a template along with the final subgrantee application materials to ease the burden on subgrantee applicants." There doesn't seem to be a legal opinion template posted to the website. Will WBO be publishing a template?

While WBO will not publish a template for the legal opinion, we are providing the following guidance on what must be included.

The legal opinion must attest that the subgrantee applicant:

- Is a duly organized and existing [legal entity] under the laws of the State of Wyoming.
- Is aware of the federal and state laws applicable to BEAD funded deployment projects.
- Possesses the qualifications and resources to perform BEAD-related commitments in compliance with all applicable federal and state laws has corporate power: (1) to execute and deliver the [Grant Agreement], and (2) to perform all acts required to be done by it under said agreement.

The legal opinion must:

- Indicate whether the subgrantee applicant is or is not currently in compliance with all relevant federal and state laws, including the Occupational Safety and Health Act and the Fair Labor Standards Act.
- Include an attached description of any known violations, current or pending investigations, or current or pending legal actions related to applicable federal or state laws The description must include any violations of federal and state labor and employment laws (including Occupational Safety and Health Act or Fair Labor Standards Act and situations where the subgrantee applicant may have relied upon contracted labor and the contractor was found to be at fault) within the previous three years and state whether any violation was associated specifically with a broadband deployment project.
- Include an attached description of the qualifications of the attorney and their familiarity with relevant legal areas and the organization.
- Be signed by the attorney (name, title, and license number).

As part of the review process, WBO will confirm that the attorney submitting the opinion is in good standing with either the Wyoming State Bar (for opinions on Wyoming law) or the bar for state in which they are licensed. WBO may disqualify subgrantee applicants who have committed past violations or who have relevant pending legal proceedings.

The quality, completeness, and information included in the legal opinion related to labor and employment practices will contribute to the applicant's score for the Fair Labor Practices criteria on the scoring rubric.

45. Is the performance bond required to equal the entire project cost? Yes.

46. If we do a performance bond in place of a letter of credit, do we have to do anything else? Is it one or the other?

You will choose to obtain either a performance bond or a letter of credit.

47. We are seeing discrepancies in the number of locations in the Project Area Unit between what we can see and the FCC fabric. Why is that?

Changes in BEAD-eligible locations occur with each new iteration of the FCC's National Broadband Map. The Wyoming BEAD Challenge Process used National Broadband Map Fabric version 3.2; the current Map Fabric version is 5.0. Discrepancies in the number of locations may also stem from enforceable commitments from grant awards issued after the Challenge Process ended. For example, WBO recently awarded new Connect Wyoming Capital Projects Fund (CPF) grants. (See Question 54 for more information on these locations.)

To handle the discrepancies in locations that arose between the approval of Challenge results and the deployment of the project, subgrantee applicants will document Broadband Serviceable Locations (BSL) believed to be invalid. (For more information, see Question 43.) Subgrantee applicants can use a template provided by NTIA and apply standard Reason Codes to indicate why the location should not be served with BEAD funds. Subgrantee applicants will maintain evidence supporting the reason. For more

information on Reason Codes and evidence best practices, see NTIA's Final Proposal Guidance version 1.2, pp. 41-46: https://www.ntia.gov/sites/default/files/2024-11/bead final proposal guidance v1.2.pdf.

48. If deduplicated locations are removed from a PAU, does the project benchmark cost reduce as well?

No. The project benchmark cost is not affected by the deduplication of BEAD locations. If a location is successfully identified as a non-BEAD location, WBO will not fund it with BEAD money. (For more information about locations that have been awarded through Connect Wyoming Capital Projects Fund grants after the Challenge Process, see also Question 54.)

49. How am I supposed to quantify in-kind match? If we have middle-mile infrastructure in place prior to the BEAD grant and that infrastructure allows us to get to those BEAD locations at a lower cost, can that be considered an in-kind match and part of the 25 percent?

Matching funds are required to be necessary and allocable. Not all your middle-mile infrastructure will be allocable. You can claim the specific part of the middle mile used in the delivery of last-mile service to BEAD-funded locations. See, NTIA's BEAD Match Primer:

- **50.** Will WBO publish a draft subgrant agreement before the application window closes? Yes.
- 51. The NTIA BEAD Letter of Credit Waiver has two options: step-down over the course of the project, or an alternative (suggested 10 percent) reduced rate for each 6-month block for that block's total. Will both methods be supported?

Yes. You can use either method 2.3 "Reduction of LOC/Performance Bonds Upon Completion of Milestones" or 2.4 "Subgrantee Option for Alternative Initial LOC or Performance Bond Percentage." See: https://broadbandusa.ntia.gov/funding-programs/policies-waivers/BEAD-Letter-of-Credit-Waiver.

52. If we expect that a project cost will be negotiated down during the post-application negotiation phase, can we use that information to obtain a letter of credit or performance bond? During the Application Phase, WBO does not require the letter of credit (LOC) or the performance bond—just a commitment to provide an LOC or performance bond. The actual LOC or performance bond will not be required until the grant agreement is finalized. WBO will work with prospective subgrantees to support a reduced LOC or bond amount request that would result from negotiations.

Overall, subgrantee applicants should structure their applications to work best for their business case. WBO encourages responses that will open the door for discussion.

53. What qualifies as completion on the timeline for subscriber activations?

The subscriber activations milestone in the Project Timeline Template should represent only the subscriber activations that you expect to be reimbursed for by the BEAD program. WBO is aware that subscriber activations are a continual activity after BEAD funding ends. In the Project Timeline Template, subgrantee applicants should indicate the subscriber activations up until the month where they propose

their project closeout milestone, which represents the submission of their closeout materials and when the applicant will no longer be seeking reimbursement from the BEAD program.

54. How will we know what locations are being covered by the Capital Projects Fund and therefore not eligible for service through BEAD?

WBO will update the Wyoming Broadband Map by early January 2025 to indicate that locations to be served through two recently awarded Connect Wyoming Capital Projects Fund (CPF) grants will not be eligible for inclusion in BEAD projects. New CPF projects are in the Cody Southfork, Opal, and Park County 4 CPF project areas. These new project locations are based on the Lightbox fabric; these locations will be associated with FCC Broadband Map location IDs, which will be used for CPF reporting. WBO will provide updated data for BEAD-eligible locations and Project Area Unit information that is aligned with updates to the Wyoming Broadband Map. 55. Will Wyoming accept a surety (performance bond) letter of intent at 10 percent of award or require 100 percent of awards at this stage of the application process?

Per the NTIA BEAD Letter of Credit Waiver, you can use either method 2.3 "Reduction of LOC/Performance Bonds Upon Completion of Milestones" or 2.4 "Subgrantee Option for Alternative Initial LOC or Performance Bond Percentage." (See Question 51 above.) Section 2.4(c) in the Waiver specifies that, "The subgrantee commits to maintain a letter of credit or performance bond in the amount of 10% of the subaward until it has demonstrated to satisfaction of the Eligible Entity that it has completed the buildout of 100 percent of locations to be served by the project or until the period of performance of the subaward has ended, whichever occurs first." 56. Is match included in the Total Project Cost? When calculating the percentage of the benchmark for the "minimal BEAD program outlay" scoring criterion, should we use the Total Project Cost, or the total cost less the match (Total Funding Request)? For example, the scoring rubric says, "if an applicant's cost is 40 percent of the benchmark, the applicant will receive 40 points, calculated using the following formula: 50 - (0.4*25) = 40 points received." In that case, if the benchmark is \$250,000 and the subgrantee applicant's cost is \$100,000, is that \$100,000 exclusive of the match?

The Total Project Cost is equal to your Total Funding Request plus Total Match. In the case provided, the "subgrantee applicant's cost" of \$100,000 refers to the Total Funding Request, not the Total Project Cost. The "minimal BEAD program outlay" score is calculated by taking your Total Funding Request,

which excludes the match, as a percentage of the benchmark. For more information, see:

In addition, note that WBO will review all applications and may conduct negotiations regardless of the application's score against the benchmark.

57. If multiple PAUs are included in one application, how is that application scored—in total/aggregate across all PAUs or individually by PAU? Would that mean separate PAU project costs must be submitted with the one application?

The application is scored in aggregate. However, WBO is requesting cost to be broken down by PAU in the Census Block Group template to facilitate any required negotiation.

58. On the Census Block Group template, subgrantee applicants are required to specify the amount of funding being requested per PAU. Several of our projects encompass multiple PAUs. It is not feasible to accurately allocate a per-PAU cost because the projects were not modeled on a per-PAU basis. How should applicants handle this scenario?

WBO understands that multiple PAUs may be encompassed in a single application and that the subgrantee applicant may provide a single design for all submitted PAUs. Understanding that each PAU is not a "standalone" project, the subgrantee applicant should request an allocation of funding for each PAU that matches their business case to serve the locations contained within that PAU. Providing this information to WBO will support the negotiation process.

59. Will WBO extend the application deadline, given the potential level of rework implied and major holidays coming up?

Unfortunately, WBO cannot extend the application deadline. Compliant applications are required to propose service to 100 percent of the eligible BSLs contained within the PAUs they are proposing. The WY High Cost Location Identification and Price Reduction Template is intended to be an additional opportunity for the subgrantee applicant to identify potential locations for descoping via the negotiation process. This document is optional and not required if the subgrantee applicant intends to serve the entirety of the PAU(s). (The template is available at:

Note: WBO extended the application deadline to January 24, 2025, 5 p.m. MST to allow subgrantee applications adequate time to review the subgrant agreement.

60. For locations in a PAU that we want to highlight as high cost and decouple from an all-fiber bid, should we include the grant amount reduction for each location individually?

Yes. The subgrantee applicant should identify locations within a PAU that are exceedingly high-cost and prevent the subgrantee applicant from providing a proposal that approaches the PAU reference price. This data on high-cost locations is for informational purposes and will facilitate any required negotiations.

61. Do we need to provide the per-location cost to serve for locations we believe are serviceable/non-high cost?

You do not. Subgrantee applicants are required to provide cost information on a PAU basis. The only location-level cost detail required is related to the descoping of high-cost locations.

62. There appear to be locations covered by an RDOF award in areas which we may be interested in applying for. Do we address those locations through the removal process or is WBO intending to fund those locations?

In finalizing the list of eligible locations for BEAD, WBO deduplicated locations with enforceable commitments if the RDOF awardee proposed service that meets the BEAD program performance and technology standards. If the RDOF awardee proposed service that does not meet BEAD standards, locations included in the project are eligible for BEAD. If the subgrantee applicant has evidence that the project proposed for the identified locations meets BEAD standards, they may provide that information within their application using the "Non-Served Locations" spreadsheet. Directions for this submission can be found in the instructions for Question 4.2 in the Application User Guide v1.3: https://broadband.wyomingbusiness.org/wp-content/uploads/2024/12/Application-Guide-v1.3-20241213.pdf.

63. Is there or will there be a sample award agreement we can review?

WBO will publish a draft subgrantee award agreement before the Application Phase closes, at which time WBO will notify each prequalified applicant via email that the draft subgrantee award agreement is posted on WBO's website.

64. Our parent company and one subsidiary will submit applications, and we have a bond commitment letter for our parent company. Do we need separate bond commitment letters for each entity applying for a grant, or can we use the letter for the parent company for both?

A letter of commitment from a qualified financial institution is required for each application. The parent company may provide a letter of commitment for the subsidiary's application if the commitment covers

company may provide a letter of commitment for the subsidiary's application if the commitment covers the specific application. The letter of commitment should reference the parent company's capabilities to meet the requirements of the subsidiary's application.

65. When are descoping files due and how should we include these in our application? Subgrantee applicants shall provide a proposed design and cost to serve all BEAD-eligible locations in the PAU. In addition, a subgrantee applicant may propose to descope BEAD-eligible locations from the project that it either deems are too high cost to practicably serve through its technology solution or demonstrates are not eligible. Depending on the reason for the proposed descoping, upload the

applicable optional template(s) in response to Question 4.2 in the application as follows:

- Use the High Cost Location Identification and Price Reduction Template spreadsheet to identify by location cost, the locations in the PAU that are not cost-effective to reach (by PAU ID and FCC Location ID). This information will be used in negotiations.
- Use the Non-Served BEAD Locations Template to identify BEAD-eligible locations that the
 applicant can demonstrate are not eligible (e.g., locations that are already funded or not a real
 site). Enter location IDs and reason codes; the applicant must also provide evidence. (See
 Question 43 in this FAQ document for instructions.)

If applicable, these template file(s) should be submitted with your application. The application window closes on January 24, 2025.

66. Question 6-1a in the portal asks for multiple files but the portal only shows the first. Is there a way to validate that both/all files are uploaded?

You can upload multiple files. You can verify whether files have been uploaded by checking in the portal's File Manager.

67. Can we include multiple BSL IDs per line in the cost reduction spreadsheet?

Include only one BSL per line in the High Cost Location Identification and Price Reduction Template.

68. Where did you post the template(s) for the explanation of high-cost locations and the cost reduction?

Use the Wyoming High Cost Location Identification and Price Reduction Template to provide high-cost locations you propose to remove and the cost reduction per location. This and other templates are available on WBO's BEAD Grant Application webpage:

69. Why did WBO extend the application deadline to January 24, 2025?

WBO extended the application deadline to January 24, 2025, at 5 p.m. MST so that subgrantee applicants have adequate time to review the subgrant agreement.

70. The Project Costs Template asks for a date of completion. Is that the date the application is submitted or the anticipated date of completion of the project?

The date of completion refers to the completion of the BEAD project.

71. Do letters of support have to be merged into one file or can these be separate files?

The initial letter of support should be uploaded separately as an individual file in response to question 3.8A. You may merge other letters of support into a single file to upload in response to question 3.8C. However, the portal will allow you to upload up to 10 files for this question.

72. Is WBO firm about requiring a legal opinion at this stage of the process? The information being requested to be opined to is generally not part of an attorney's opinion or would be provided at the agreement signing stage.

Question 5.12 requires a legal opinion that demonstrates the subgrantee applicant's ability to carry out BEAD-funded activities competently and in compliance with applicable laws. See also, Question 44 above.

73. How do you want us to report the unserved versus underserved ratio—just in the technical narrative? Is there a specific place you will look in the application for that data?

You do not need to report the ratio of unserved to underserved locations in your application beyond what you choose to include in the technical narrative. WBO can derive this information for PAUs.

74. Will grant fund reimbursement be tied in any way to match expenditure?

This information will be included in the draft subgrant agreement, which WBO will make available to subgrantee applicants on the WBO BEAD Grant Application webpage before the Application Phase closes.

75. What does the timeline look like after applications are submitted? How long will the state need to review and start the negotiation phase?

The timeline for review and beginning negotiations will depend on the completeness and accuracy of applications. Once it begins reviewing applications, WBO will determine to what extent curing is required.

WBO is required to submit its provisional awardees with its Final Proposal to NTIA by July 29, 2025 (one year after NTIA approved its Initial Proposal volume 2) but anticipates completing subgrantee selection and submitting the Final Proposal before that date. WBO's goal is to enable awardees to build in the 2026 build season.

76. What does WBO consider as "built/connected?" Is it actual end user locations or those that can be "built to within 10 days of reasonable request?" How does WBO anticipate handling locations not built to or taking service against a subgrantee's build obligation?

WBO considers locations that can be provided service within 10 days of reasonable request as "built"/ "connected." The BEAD subgrantee's obligation is to connect each location. Locations that are connected but have not requested service will be considered connected.

77. Will benchmarks be recalibrated based on locations included in the high-cost location spreadsheet? Does the high-cost location spreadsheet impact the price point calculation?

No, benchmarks will not be recalibrated based on the identification of high-cost locations in the Wyoming High Cost Location Identification and Price Reduction Template. Information that subgrantee applicants include in this spreadsheet will help facilitate the negotiation process.

78. The WY subgrant agreement doesn't specifically call out that the state will treat BEAD awards as fixed amount subawards. Does WBO plan to include updated language to address this and the elements not applicable to fixed amount subawards that are applicable under other circumstances (for example, cost principles under 2 CFR 200 not applicable to fixed amount subawards)? The current draft also seems to include obligations under all award types, but 2 CFR points out that various pieces of compliance that are currently included in the WY draft agreement don't apply to fixed amount subawards.

The grant agreement is a single universal document as required by NTIA that may cover multiple types of projects and technologies, so the subgrantee should expect that some provisions may only apply to certain projects and project types. WBO does not plan to update the draft grant agreement at this time but will continue to review NTIA guidance for the changes needed prior to final awards.

The federal government reserves the right to modify 2 CFR § 200, and within it reserves the right to change reporting requirements when it deems necessary. Having to continuously amend guidance and

legal documents each time a change or clarification is provided by NTIA would be burdensome and likely unnecessary.

2 CFR § 200 covers standard terms and conditions applicable to federal grant awards. The Uniform Guidance Policy Notice released by NTIA for BEAD does not replace or provide a wholesale waiver of 2 CFR § 200 for fixed amount subawards. (See, https://broadbandusa.ntia.gov/sites/default/files/2023-12/BEAD Policy Notice of Uniform Guidance Part 200 Exceptions Related Issues.pdf.) The specific modification to Uniform Guidance rules for BEAD addresses certain procurement standards in 2 CFR § 200.318-320 and § 200.324-326 (See, Uniform Guidance Policy Notice, p. 7) and cost principles under 2 CFR § 200.401(a)(3). The latter are detailed cost accounting standards that usually apply to fixed amount subawards specifically but are waived for BEAD under the Uniform Guidance Policy Notice. Finally, it also clarifies how property standards apply to BEAD fixed amount subaward projects but with the very practical provision that subgrantees should use their own regular business practices for managing and tracking BEAD-funded assets.

Portal

1. Regarding the naming requirements for the attached documents, are we able to add our company name or other text behind the required format?

Yes. We recommend using an underscore (_) or hyphen (-) to separate any additional language from the required portion of the file name.

2. What are the character limits for each textbox entry?

For longer narrative responses the limit is 120,000 characters. Some response fields have a strict limit between 2-100 characters where responses are expected in a specific format. Consult the Application Guide for additional character limit length information. If you have specific issues where your narrative exceeds the character limitation, please reach out to WBO.

- 3. Is there a way to not share credentials for access to the map or application?
- While WBO enables multiple users from a company to work on a project application, map credentials are limited to one user per company. There is no specific proprietary information that can be pulled down from the map.
- 4. May more than one company personnel have application portal access and can more than one person be working on an application at the same time?

While up to two people from the same company can access the portal at the same time, WBO recommends that only one person work on a project application at a time to avoid potential for one user overwriting another's input. Two users in the company can, however, work on separate project applications at the same time. Users within the same company will be able to see all applications and statuses.

5. Does the owner of an application have special permissions related to that application? Should the user who will certify the application be the owner?

Application owners do not have special permissions. All users have equal permissions to edit and sign applications. The application owner may be, but is not required to be, the individual who certifies the application; the certifying individual should have the legal, binding authority to certify on behalf of the entity. On the certification page, the individual should provide their title and electronic signature.

6. Do all users have permissions to "Save and Proceed" when a section is completed? Yes, all users can "Save and Proceed" when a section has been completed. All users have equal permissions to edit the application.

7. How is "Step 3 - Document Management" accessed? (This step is referred to in revisions 1-8 of the FAQ document.)

The application portal no longer has a Step 3. Please refer to the BEAD Application Guide version 1.3, available on the WBO BEAD Grant Application webpage under Grant Application Materials: https://broadband.wyomingbusiness.org/wp-content/uploads/2024/12/Application-Guide-v1.3-20241213.pdf.

8. For question 4.2, when the Application Guide references .dfb and .spx file extensions, are those the correct file extension names?

No, those file extension names in the Application Guide for question 4.2 are typographical errors. The correct file extension names are .dbf and .sbx.
